Renters must provide their own insurance. The MRBC provides only secondary insurance.				
Renters are liable for damages to camp property, but not the normal use and wear of the facilities. Damages are to be repaired by the camp. The cost for such repairs will include materials and labor.				
Renters may use waterfront equipment (with the exception of motorized craft) and are responsible for the safety of boaters and swimmers. All boat passengers must <i>wear</i> an approved life vest. This includes all watercraft.				
Renters are responsible for daily cleaning of the facilities, including the kitchen. An inspection of the facility will be done before a group's stay is complete.				
Renters must abide by the rules of the camp as stated in the current camp brochure.				
	of alcoholic beverages is prohibited on camp property. No fireworks are to be used on usic (whether rock, pop or country) is not allowed on the premises of the camp.			
While pets are allowed on the grounds, they are not to be in public buildings (dining hall, office, canteen, etc.). Al pets are to be on a leash. Pet owners are to have in their possession all vaccination records. Renters are responsible to pick up after their pets. In the case of aggressive behavior towards others, the camp is not responsible or liable for any damages.				
Upon leaving the camp, renters are to sweep used cabins and place garbage in the garbage dumpster.				
RATE: The fee for rental is \$17.50 per person per day \$525.00 per day (whichever is greater). Campers ages four (4) and under will be charged the rate of \$6.00 per day. There is also a rate of \$6.00 per day for daily visitors (not spending the night). All checks are to be made payable to the Minnesota Regular Baptist Camp (MRBC).				
Speedboat use (with our driver) will be \$65.00 per hour. Climbing tower rates are \$75 per hour (for up to 10 climbers) and \$6.75 per hour for each additional climber. All climbers are to complete the camp's consent form before their climb. <i>Please note that parental permission (in writing) must be obtained for those under the age of 18 before they are allowed to climb.</i>
