BACKGROUND CHECK

Because we take very seriously our legal, moral and Biblical responsibility to provide a positive experience for all of our staff and campers, we seek to maintain a staff of blameless character and testimony. Therefore, as part of our background check on applicants, we will consult law enforcement agencies. - * In what state are you currently licensed to operate a motor vehicle?
- * List your operator's license number and type of license.
- * Do you have any reason to believe that such a background check on you would discover any negative information? If so, please explain.

I recognize that as a condition of my employment, I may be required to consent to and/or furnish to the MN. Regular Baptist Camp a criminal records check from an appropriate federal and/or state law enforcement agency, and I consent to do so, realizing the importance of promoting the camp's ability to protect its workers and those whom it serves.

I understand that this is an application for a volunteer position and that no financial remuneration will be offered. All workers are entitled to housing (if available) and meals. I further understand that the Camp Director has the right to refuse me from a position if he deems it necessary for the overall effectiveness of the camping ministry.

I certify that statements made in this application are true and complete, and that any misrepresentation or omission may be grounds for rejection of my application or for dismissal if I am given a position as a volunteer.
